Subject: Display of Provisional Answer Keys and Question Papers with Recorded Responses for Answer Key Challenge of Common University Entrance Test [CUET (UG)]-2025 -reg.

The National Testing Agency (NTA) conducted CUET (UG)-2025 from 13.05.2025 to 04.06.2025 in multiple shifts in Computer Based Test (CBT) mode across the Country and abroad for 1354699 registered Candidates. The Provisional Answer Key(s) along with the Question Papers with Recorded Responses are available on the website <u>https://cuet.nta.nic.in</u> for interested candidates to challenges. The procedure for the challenge of Answer Key is enclosed as **Annexure – I**.

2. The candidates, who are not satisfied with the Provisional Answer Key, may challenge the same by paying a fee of ₹200/- (Rupees Two Hundred only) per question challenged as a non- refundable processing fee. The duration for Answer Key Challenge is given below:

3. The payment of the processing fee may be made (through Credit Card/ Debit Card/Net Banking/UPI Payment modes) till **20.06.2025 (up to 11.00 PM).** No challenge will entertain without receipt of the processing fee. The challenge shall not be accepted through any other mode.

4. Challenges made by the candidates will be verified by the panel of subject experts. If the challenge of any candidate is found correct, the Answer Key will be revised and applied in the response of all the candidates accordingly. Based on the revised Final Answer Key, the result will be prepared and declared. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge. The key finalized by the Experts after the challenge will be final. Candidates are advised to visit NTA Official website: https://cuet.nta.nic.in for latest updates.

Procedure for Challenge of Provisional Answer Key(s) of CUET (UG)-2025 Examination

- 1. Please go to the website https://cuet.nta.nic.in.
- 2. Click 'Challenge (s) regarding Answer Key'.
- 3. Login with your Application Number and Password and enter the captcha as displayed and submit.
- 4. Click on "View Question Paper" for marked/recorded responses and to view or challenge the Answer keys, click on the link "Click to view/Challenge Answer Key".
- The Question IDs in the Answer Key list are not presented in sequential order. 5. Candidates are advised to refer to the Question Paper and match the corresponding Question IDs to those listed in the Answer Key. An example is given below:

- 6. The ID next to the question under the column 'Correct Option(s)' stands for the correct Answer Key to the question.
- 7. If you wish to challenge this option, you may use any one or more of the Option IDs given in the next four columns by clicking the check box.
- 8. You may upload supporting documents in which you can select 'Choose File' and upload (all documents to be put in a single pdf file).
- 9. After clicking your desired option, scroll down, 'Submit and review Claims' and move to the next screen.
- 10. You will see a display of all the Option IDs you have challenged.
- 11. Click on 'Modify your Claims' in case you wish to modify the claims OR 'Final Submit'.
- 12. After saving the claims, you will find a screen displaying your Challenges.
- 13. Kindly pay the fee by clicking on 'Pay Now'. The claims will be saved finally after successful payment of requisite fee.
- 14. Select mode of payment and pay your fee @ Rs.200/- for each question challenged. Make payment through Debit/Credit Card/Net Banking/UPI.
