SUPPLEMENTARY RESULT NOTICE No.86 TEACHER (PRIMARY) POST CODE-70/09 MUNICIPAL CORPORATION OF DELHI

In compliance with the order dated 08.01.2025 passed by the Hon'ble High Court of Delhi, the common order of the same date has upheld the decision of the Learned Central Administrative Tribunal in W.P.(C) Nos. 5179/2018, 6169/2018, and 7081/2018, arising out of OA Nos. 450/2015 (Durga Prashad & Ors.), 4658/2014 (Savita Chaudhary), and 2514/2015 (Suman Rohilla), as well as in W.P.(C) Nos. 56/2019 and 77/2019, arising out of OA Nos. 401/2015 (Dinesh) and 2583/2015 (Mina Kumari). The Hon'ble Court has extended the same relief granted in W.P.(C) No. 5179/2018.

Accordingly, with respect to the post of Teacher Primary under post code 70/09 in MCD, the following candidates are provisionally nominated:

The provisional nomination of the above ten (10) candidates (05 UR, 01 UR(SP), and 04 OBC) has been processed solely based on the marks obtained by the candidates in the examination conducted on 02.02.2014, as well as the claims made by them in their offline application forms for the post of Teacher Primary under post code 70/09 in MCD. The eligibility of the candidates, as per the Recruitment Rules and other terms and conditions specified in Advertisement No. 004/09, along with any relaxations allowed under the rules regarding educational qualifications, experience, etc., shall be scrutinized and verified by the User Department. This verification will determine the candidates' eligibility for post code 70/09 as on the cut-off date 15.01.2010, prior to the issuance of the offer of appointment.

The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/

documents as furnished in the dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally nominated candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level. The category wise marks scored by the last provisionally nominated candidate after this supplementary result is as under:-

The User Department, being Cadre Controlling/Appointing Authority, shall strictly follow the merit based ranking of the candidate.

The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.

The present Supplementary Result is subject to outcome of any future legal proceedings in the matter. Further, the above nomination shall not be considered as precedent for subsequent cases. The User Department shall also ensure that subsequent selection, appointment and any other action pursuant to the Court orders.
