- (i) A colour blind person will not be eligible for appointment. If at any stage of service career, a person is found to be colour blind, he will be medically boarded out as per SHAPE policy in vogue in the ITBPF.
- (ii) The candidates must not suffer from knock knees, flat foot, varicose vein or squint in the eyes and should possess high colour vision. They must be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of duties.

(b) Tattoos: -

- (a) <u>Content</u>: Being a secular country, the religious sentiments of our countrymen are to be respected and thus, tattoos depicting religious symbol or figures and the name, as followed in Indian Army are to be permitted.
- (b) <u>Location</u>: Tattoos marked on traditional sites of the body like inner aspect of forearm but only left forearm, being non saluting limb or dorsum of the hands are to be allowed.
- (c) <u>Size</u>: Size must be less than ¼ of the particular part (Elbow or Hand) of the body.

Note :-

In case, a candidate has undergone removal of tattoo (s) prior to appearing for recruitment process and the same has faded substantially, this will be treated as a "scar" and not a tattoo. Such candidates will be permitted to undergo the entire selection process with the approval of Presiding Officer of the recruitment Board. Further, the scar resulting due to removal of tattoo will be reviewed by the Medical Board of Officer during Detailed Medical Examination (DME).

a) Eligible and interested candidates need to apply online through ITBPF website https://recruitment.itbpolice.nic.in. Candidates are advised to fill the application form after reading the instructions carefully and should provide genuine and functional e-mail ID and Mobile number at the time of

- filling online application form. Details as required under various segments should be mentioned clearly, correctly and logically. As the applications need to submit online only, application received offline shall not be considered and will be rejected summarily.
- b) Candidates are to fill all information e.g. Gender/Category (UR/SC/ST/OBC (NCL)/EWS etc), Employment status/Riots affected, etc. in the profile created on ITBP recruitment website before submission of online application. Any false/incorrect information in online application will lead to cancellation of candidature and no request for change in such details will be considered at later stages.
- c) APPLICATION FEE & MODE OF PAYMENT Candidates belonging to General (UR), OBC and EWS category applying for this recruitment will have to pay Rs. 100/- (Rupees one hundred only) as application fee through online payment gateway system on https://recruitment.itbpolice.nic.in. Application received with any other mode of fee payment will be summarily rejected. Candidates belonging to Scheduled Caste, Scheduled Tribe and Ex-servicemen are exempted from paying the fee.

mentioned in writing in the rejection slip. In case, if candidate is not satisfied with the physical measurement recorded by the Board, he may make a representation/appeal in writing to the Presiding Officer of the Recruitment Board on the same day for re-measurement. In such case, the physical measurement of aggrieved candidate(s) shall be measured by the Presiding Officer himself and shall dispose off the representation/appeal immediately in writing to the candidate then and there. MERIT LIST

- (i) After completion of Practical (Skill) Test, Merit list in each category namely UR, SC, ST, OBC (NCL), EWS and Exservicemen will be drawn on the basis of marks obtained by the candidates in the written examination. On the basis of merit, the candidates shall be shortlisted for Detailed Medical Examination (DME) as per the category-wise vacancies. The number of candidates examined will be equal to the number of vacancies increased by average failure rate of Detailed Medical Examination (DME) and Review Medical Examination (RME) determined on the basis of past experience. However, there shall be no reserve list.
- (ii) SC, ST, OBC (NCL) & EWS candidates who are selected on their own merit without relaxed standards will not be adjusted against the vacancies of reserved categories. Such SC, ST, OBC (NCL) & EWS candidates shall be accommodated against the General vacancies as per their position in overall merit list. The reserved vacancies will be filled up separately from amongst eligible SC, ST, OBC (NCL) & EWS candidates which will thus, comprise of SC, ST, OBC (NCL) & EWS candidates who are lower in merit than the last General candidate on merit list of unreserved category but otherwise found suitable for appointment even by relaxed standard.

(i) All candidates declared unfit during Detailed Medical REVIEW Examination (DME) will be allowed to undergo Review MEDICAL EXAMINATION Medical Examination (RME), subject to providing their written consent by appending their signature on the intimation (RME) indicating the reasons for being unfit as per Annexure-'VII'. (ii) The candidates who have been declared unfit in DME will be briefed about the procedure for filing an appeal for RME at the venue. (iii) The RME of candidates will be conducted continuation of DME preferably on the next day of DME. The consent for RME as per Annexure-'VII' duly signed by the candidate should be submitted within 24 hours after he/she is informed of his/her unfitness in DME. Data of such candidates who are declared not qualified in DME and submit written consent for RME will be provided by the Presiding Officer to the RME Board. There should be no provision of "Temporary Unfit". Medical Officers should given their verdict as "FIT" or "UNFIT" in respect of each candidate. (v) The decision of the Review Medical Board of ITBPF shall be final for declaring a candidate 'Fit' or 'Unfit' in Review Medical Examination (RME) and no 2nd appeal will be entertained and reply of the correspondence/2nd appeal will also not be given/entertained.
